SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

General information:

Tissue-damaging effects: This product contains substances with skin corrosive properties. Inhaled vapour or aerosols may produce adverse effects to lungs, irritations and burns in the respiratory organs as well as coughing. Dermal contact and contact with the eye cause irreversible effects.

SECTION 5: FIREFIGHTING MEASURES
